

ABEL RENTAL AGREEMENT – DISCLOSURE

Abel chooses to proactively bring the following terms and conditions to your attention. Although these terms and conditions exist on the current rental agreement, Abel; unlike other rental operators, likes to clarify and be sure that they are understood before you hire a vehicle with Abel.

*** RENTER'S INFRINGEMENT FINANCIAL RESPONSIBILITIES ***

The Renter, joint hirer, credit card holder is fully responsible for all fines, infringements, tolls/etag payments, penalties and associated administration costs. (See clause 5 of the terms and conditions)

*** RENTER'S DAMAGE FINANCIAL RESPONSIBILITIES ***

The Renter is fully responsible for all damage and associated costs not covered by insurance. The Renter will NOT be covered by insurance (but not limited to) the following circumstances:

- Single Vehicle Incidents;
- All off sealed road driving;
- Late unauthorised return of Vehicle;
- Collisions with stationery parked vehicles
- Use of Vehicle outside of QLD, NSW & VIC;
- Where the Renter has been Grossly Negligent;
- Where the Renter admits to fault to a third party; and when the Vehicle has been stolen;
- Any breach of the road laws rules and regulations and any conviction of a traffic offence causing damage

*** MULTI-VEHICLE INCIDENT INSURANCE COVERAGE SUMMARY ***

STANDARD INSURANCE Renter's maximum liability in multi-vehicle accidents:-

- Passenger \$4,400, Utilities \$6,600, Trucks \$8,800; plus contractors claim processing fee of \$275.00 + an independent Assessors Report Fee of \$220.00 + any additional charges regarding all vehicle towing, vehicle storage; administration and credit card surcharges. (See clause 4 of the terms and conditions)

OPTIONAL COLLISION DAMAGE EXCESS REDUCTION Renter's maximum liability in multi-vehicle accidents:-

- Passenger \$440, Utilities \$660, Trucks \$880; plus contractors claim processing fee of \$275.00 + an independent Assessors Report Fee of \$220.00 + any additional charges regarding all vehicle towing, vehicle storage; administration and credit card surcharges. (See clause 4 of the terms and conditions)

*** OTHER CHARGES ***

- Administration processing fees: Parking fines, speeding fines, red light camera fines fee (\$99.00 each) and Tolls/E-Tags Infringements fee (\$55.00 each), road-side assistance due to Renter error, etc.(\$75.00 each)
- Credit Cards: Administration charge of 5.5% and a credit card surcharge 2.75 % when paying by credit cards.
- Stolen Vehicle (no keys returned): \$10,000 down payment plus plus a recovery fee of \$1,100
- Stolen Vehicle (keys returned): \$5,500.00 down payment plus a recovery fee of \$550.00
- Cleaning charge: A minimum professional cleaning charge for all vehicles of \$275.00
- Refuelling service charge: \$2.20 per litre with a minimum charge of \$ 30.00
- All charges regarding vehicle towing and vehicle storage

*** NOTES ***

The Renter's pre authorization / security bond (minimum \$100 for cars, \$200 for commercials) amount can fall off the account (thus rendering the balance available again) anywhere from 21 days after the transaction date depending on the issuing bank's policy. The Owner does not bank these funds into its account, the Renter's funds are held by the Renter's bank.

The Renter must return the vehicle by the due date and time on this Rental Agreement, otherwise the Vehicle will be reported to the Police as being stolen by the Renter and all insurance cover will be void. For all your rental extension needs, please call your local office as listed on your Rental Agreement.
